

Denver Indian Family Resource Center (DIFRC) was founded in collaboration with metro Denver Native community non-profit organizations and Casey Family Programs to address the overrepresentation of American Indian and Alaska Native (AI/AN) families in the child welfare system, a historic and ongoing challenge in AI/AN communities across our nation. Culturally responsive services and advocacy were identified as critical steps to address the situation. DIFRC was created to offer services based in the spirit of the Indian Child Welfare Act (ICWA). We strive to keep children safely with their families as we weave cultural strengths and traditions that promote family resiliency into our practice of collaborative support.

It is estimated that currently Colorado is home to more than 126,000 AI/AN people, with approximately 62,000 or 50% living in the Denver-Metro area. DIFRC serves as a single point of entry for comprehensive, intensive, and collaborative family-based services in the metro Denver community. We work to provide reunification and preservation services for families involved the child welfare system or at risk of becoming involved. We also offer resource and referral services for families in need.

Serving Our Community



In 2019, 152 families engaged with DIFRC by participating in one of our Family Development Programs or by accessing Resource and Referral services. 91% of these families self-identified as AI/AN, and most families resided in the Denver-Metro Area, with 86 families served in Denver County, 32 in Jefferson County, 15 in Adams County, 15 in Arapahoe County, 2 in Broomfield County, and 1 in Boulder County.

Our 2 Family Engagement Specialists collaborated with County Workers to provide culturally responsive support for 31 AI/AN families as they navigated child welfare proceedings in 2019. Family development support was provided in the form of 1096 home visits, 116 supervised visits, 75 Nurturing Parenting Program education services, and ongoing ICWA court advocacy.

DIFRC works to strengthen connections throughout the AI/AN community by engaging in resource navigation with families. DIFRC provided 749 direct basic needs services in 2019 including transportation, utility, and food assistance, baby supplies, school supplies, and children's coats. DIFRC connected families to additional resources by initiating 367 formal referrals to 95 other local agencies in 2019.
