Family resource centers serve thousands of families in Colorado with many strengths, diverse needs, and a readiness to change. Both before and during the COVID-19 pandemic, these families demonstrated significant improvements in economic self-sufficiency and health. These evaluation results confirm FRCA's efforts around increasing the validity of our model.

We utilize organizational surveys and fidelity monitoring of all members to identify key areas for improvement. At the center level, evaluation of outcomes and progress is measured by participant activity and feedback obtained by participant surveys and interviews.

FRCA has been working for more than 23 years to connect its network of member family resource centers to the tools, technical assistance and resources needed to promote organizational excellence and sustainability. These organizations provide a powerful safety net of community-based family support programs and services for families in Colorado. Currently, FRCA's member network consists of 32 family resource centers serving 57 counties in Colorado. These organizations continued to serve as vital community hubs throughout the COVID-19 crisis.

As an intermediary, FRCA creates opportunities for replicating successes - whether it is a program design, a multi-sector solution, or a set of professional standards. FRCA is an experienced collaborator, working with

In addition, FRCA has taken an equity stance and embarked on a journey to adopt an organizational equity perspective to advance the ability of the organization and its network to develop and strengthen the skills necessary to advocate for and promote a more equitable environment. FRCA and its members have created individual health equity plans to guide implementation of strategies and objectives for continuing to advance health equity practices into the future.
